#### RESOLUTION OF BOARD OF DIRECTORS OF EVERGREEN COMMUNITY ASSOCIATION

WHEREAS, Section 7212 of the California Corporations Code authorizes the board of directors of a nonprofit mutual benefit corporation to create executive committees as the board of directors desires, and establish the purposes and powers of each such committee created; and

WHEREAS, the board of directors of Evergreen Community Association ("Association") has determined that it would be in the Association's best interests if an executive committee were created for the purpose of exercising all of the power of the Association's board of directors with respect to association finance as follows (the "Matters"):

- Consistent and real time review and monitoring of the association's finances, expenses, investments, and cash flow to ensure fiscal health, uninterrupted community operations and financial responsibility.
- Review of requests from Management for operating and reserve expenditures, including authorization for repairs that are within established budget categories and limits.
- Reserve Expense Authorization approval, including check preparation and signatures.
- Monthly financial statement review in accordance with Civil Code §5500 if no meeting is held that month.
- Preparation of the Association's annual budget and reserve study, including recommendations to the board.

NOW, THEREFORE, BE IT HEREBY RESOLVED, that there is created an executive committee ("Committee") for the purpose of exercising all of the power of the Association's board of directors with respect to the Matters;

RESOLVED FURTHER, that Association directors <u>Clyde Roe and David Ehrlich</u> are hereby appointed to the Committee and no person not appointed by the board of directors may serve on the Committee; and

RESOLVED FURTHER, that the Chairman of the Committee shall be <u>David Ehrlich</u> until such time as the board of directors appoints someone else to serve as Chairman; and

RESOLVED FURTHER, that only Association directors may serve on the Committee and any member of the Committee who ceases to be an Association director shall automatically be removed as a member of the Committee; and

RESOLVED FURTHER, that the board of directors may remove members of the Committee and appoint eligible persons to serve on the Committee in the sole and absolute discretion of the board of directors; and

RESOLVED FURTHER, that the Committee shall be terminated and dissolved at such time as the board of directors votes to terminate and dissolve the Committee; and

RESOLVED FURTHER, that the Secretary of the Association is hereby directed to insert this Resolution into the Association's minute book.
